1. Authorization for Employment/Educational Information.

I hereby, waive written notice that employment information is being provided by any person or organization.

2. Employment at Will.

If I am hired, in consideration of my employment, I agree to abide by the rules and policies of Camp Tall Turf, including any changes made from time to time, at the option of Camp Tall Turf and its designated authorities. All employees are employed at will. This means that just as I am free to terminate my employment with Camp Tall Turf at any time and for any reason, Camp Tall Turf also retains the right to terminate my employment with Camp Tall Turf at any time and for any reason.

3. Criminal Records Check.

I agree to execute an authorization for Camp Tall Turf to secure criminal conviction history from law enforcement agencies and legal records.

4. Release of Medical Information.

5. Drug and Alcohol Testing.

I agree to take a drug and alcohol test and authorize Camp Tall Turf or its designated agent(s) to withdraw specimen(s) of my blood, urine or hair for chemical analysis, if Camp Tall Turf so elects. One purpose of any chemical analysis is to determine or exclude the presence of alcohol, drugs or other substances. I understand that decisions concerning my employment will be made as a result of any chemical analysis.

6. Time Limit on Lawsuits
